LIMITED PUBLIC PERFORMANCE LICENSE

This agreement ("Agreement") between Alaska Film, LLC ("Licensor") and the purchaser ("Licensee") is entered into in connection with the purchase of the enclosed educational DVD/Blu-Ray package of the motion picture "Wildlike" ("Picture") and accompanying poster and curriculum materials ("Curriculum Materials" and together with the DVD/Blu-Ray of the Picture, the "Educational Package") for the limited public performance of the Picture for the purpose of educating viewers and raising awareness concerning sexual abuse. By purchasing the Educational Package, Licensee agrees to all terms and conditions of this Agreement. The Agreement begins on the date the Licensee pays in full the purchase price for the Educational Package and all applicable shipping fees, and will stay in effect for seven (7) years thereafter ("Term"). This Agreement shall automatically terminate at the end of the Term unless earlier terminated by Licensor hereunder.

Subject to the terms of this Agreement, Licensor grants to Licensee a limited, non-exclusive, non-transferable, non-sublicensable right to publicly perform the Picture ("publicly perform" shall mean to show, screen, and/or otherwise provide the Picture in its entirety for viewing to an audience) solely for the purpose of educating viewers and raising awareness in accordance with the following:

- Licensee may not perform the Picture for the purpose of making a profit. All screenings must be either free or for the purpose of raising money for a charitable cause.
- Licensee may distribute the Curriculum Materials solely in connection with authorized screenings of the Picture. Licensee may not alter the Curriculum Materials in any way and may not create its own materials relating to the Picture and/or edit the Curriculum Materials in any way without the express written consent of the Licensor in each instance.
- There is no limit to the number of times Licensee may screen the Picture at the Permitted Venue during the Term.
- Licensee may exhibit the Picture solely at "Permitted Venues." "Permitted Venues" mean the following venues solely within the United States and Canada: primary schools, middle schools, high schools, colleges, universities, distance learning programs, libraries, museums, non-profit organizations, religious institutions, and community centers.
- All rights not expressly granted to Licensee under this Agreement are reserved by Licensor. Licensee shall not make, authorize or permit any use of the Picture, Curriculum Materials and/or any other materials relating to the Picture except solely as expressly permitted hereunder. There shall be no editing of the Picture.

Speaking Services / Q&A: In the event Licensee desires for the Picture's writer and director, Frank Hall Green, to appear for a question and answer session after any screening, Licensee shall contact Licensor regarding Mr. Green's personal appearance and, subject to Mr. Green's availability, shall provide Mr. Green with all transportation and hotel accommodations as are required by Mr. Green in connection with such appearance. Licensee shall also reimburse Mr. Green for any additional expenses that may be required in connection with such appearance.

Licensee represents and warrants that Licensee has the full right and authority to enter into this Agreement and shall comply with all of its terms. Licensee shall indemnify and hold harmless Licensor from and against any claims, damages, fees, and expenses that may be incurred in connection with any screening of the Picture. Licensor may in its sole discretion terminate this Agreement in the event of a breach of this Agreement by Licensee that is not cured (solely if capable of cure) within thirty (30) days and/or in the event of bankruptcy, insolvency, liquidation or similar proceedings entered into by or against Licensee.

At all screenings of the Picture, Licensee shall publicly thank "the producers of Wildlike including writer/director Frank Hall Green" for providing the Picture and shall announce that Wildlike is available on cable, on demand online and on DVD. Licensee shall direct attendees to Wildlikefilm.com for details. Licensee shall use best efforts to prevent unauthorized use and viewing of the Picture and shall immediately report to Licensor any such unauthorized use. This Agreement shall be governed in accordance with the laws of the United States and the State of New York, without regard to its or any other jurisdiction's laws governing conflicts of law. This is the entire agreement of the Parties and supersedes any previous agreements or understandings. Licensee may not assign this Agreement or any rights hereunder. This Agreement may not be modified or amended unless by an agreement in writing signed by the parties hereto.
